Home Collection Kits

Home Collection kits are offered in a variety of configurations to collect mouth swab samples, urine samples and stool samples. We can also facilitate in-home blood sampling, pharmacodynamics and pharmacokinetic sampling, and pharmacogenomics sampling where needed. Eurofins provides the logistical support to deliver all collected specimens to their final destinations by arranging courier pick-up for time-sensitive specimens, or usage of regular postal services for specimens that are not time-critical.

True Global Coverage

Eurofins BioPharma Services uses three dedicated wholly-owned and purpose-build Kit Packing Facilities in Louisville, KY, USA, in Oosterhout, the Netherlands, Europe, and in our Shanghai, China Central Laboratory facility to support China domestic clinical studies. Every year, about 1.2 Million specimen collection kits are shipped to investigator sites, health care professionals and patients' homes across 85 countries. All Kit Packing Facilities deploy lean, globally standardized processes and our operations have embedded flexibility to handle fluctuations in demand, allowing quick expansion of services.
